3 Section 1. Composition of Board

4 (A) The Board of Directors shall consist of the state officers of the Union, one 5 representative from each district for each one/twenty-fifth (1/25), or major fraction thereof, of 6 the total active Union members in the state but no less than two (2) representatives from each 7 district and one retiree representative.

8 (B) The number of members eligible for election to the Board of Directors shall be 9 limited to one person from either a governmental entity or Chapter in the district in which the 10 Chapter is located.

11 (C) No vacancy shall exist by virtue of a failure of a District to elect the number of 12 Board of Directors members to which it is entitled. In the event such a failure occurs, a non-13 voting District Representative shall be selected pursuant to Board Policy.

(D) If a state bargaining unit, or aggregation of local government bargaining units, consisting of at least one/twenty-fifth (1/25) of the total active membership is not represented by an officer or member of the Board, a special Board seat shall be added to the Board and shall be filled by election by the Board from among nominees who are active members in such bargaining unit. Procedures for such election shall be the same as those used to fill a vacancy on the Board.

and/or adopt provisions of the OCSEA State Constitution, By-Laws and/or Subordinate Body
Constitution.

30 Said provisions may be approved at a regular or special meeting of the Board of31 Directors.

(B) Notice of this Meeting shall be displayed prominently on the OCSEA website and
 distributed by any other available electronic media. Said notice shall include all Subordinate
 Body Presidents.

35 (C) All proposed changes must be presented in writing. A quorum must be present. It 36 shall require a two-third (2/3) vote of all members of the State Board to revise and/or adopt the 37 temporary provisions.

38 (D) All changes shall be posted on the OCSEA website and distributed via any39 electronic media immediately following the meeting.

40 (E) If passed, these temporary provisions will remain in effect for the length of the 41 emergency situation or until the Board rescinds, if earlier than the end of the emergency. Any 42 temporary, emergency measures still in place at the time of the next biennial convention shall be 43 presented to the Convention for consideration.

45 Section 4. Qualifications for Board Membership

46 (A) Only such employees who are active members of the Union for a period of at least
47 two (2) continuous years immediately prior to election or appointment shall be eligible for
48 election or appointment to the Board of Directors.

- 53 (C) No potential candidate shall be nominated, elected or appointed for a seat on the 54 Board of Directors in the Union if after conviction for a felony, it is less than five (5) years after 55 completion of the sentence and/or the probation for said felony.
- 56 (D) Affiliation with a competing labor organization shall disqualify a member from 57 nomination, election, appointment to or maintenance of a seat on the Board of Directors.

59 Section 6. Election to the Board

60 (A) The authority for the conduct of Board of Directors' elections is defined in the 61 Constitution. All active members shall vote in the district which contains the Chapter to which 62 the member is assigned, regardless of their place of residence.

63 (B) An outside accounting firm shall be hired to handle all district elections to the 64 Board of Directors. It shall be the responsibility of said firm to prepare the ballot, mail to 65 member's address, collect, tabulate, and certify the results of election to the officers and all 66 Board of Directors members, as well as all candidates. The firm shall be selected by the Board of 67 Directors. Ballots shall be mailed to a member's address and shall be returned to the selected 68 firm within 20 days. The ballots shall include the last acceptable postmark date by which ballot 69 must be returned.

70 (C) JIAC may explore and recommend that the Board of Directors consider 71 adding electronic and/or phone voting options that will allow greater participation from 72 members.

A vacancy in office shall exist whenever a Board of Directors member is removed for 100 101 just cause or is involuntarily off the public payroll in excess of ninety (90) days, for other than a 102 medical leave of absence. No vacancy shall exist by virtue of illness, job abolishment, transfer, 103 layoff or any austerity program, or while any appeal of an employer action is in progress. 104 However, this section in no other way alters the qualifications for Board membership as provided 105 in the State Constitution Article IV, Section 3(B) upon expiration of such member's term. In the 106 event of a leave of absence, an appropriate period may be recommended by the Judicial and 107 Internal Affairs Committee and then may be approved by the Board of Directors.

109 Section 10. Board Meetings/Quorum

110 A majority of the Board of Directors shall constitute a quorum for the purpose of 111 conducting and transacting business. Meetings of the Board of Directors shall be held bi-monthly 112 at such times and places as it may determine. Special meetings may also be called as provided 113 for in the State By-Laws Article II, Section 2.

115 **Section 11. Corporate Action**

- 116 Members of the Board of Directors shall constitute the Board of Trustees as provided in 117 the statutes for the purpose of corporate action.

119 Section 12. Notice of Board Members to Subordinate Bodies

120 After the Board of Directors' election, the Secretary-Treasurer shall publish in the OCSEA Publication and send a list of the names, addresses, districts served, and department by 121 122 which employed, of all members of the Board of Directors and the state officers to the president 123 of each Chapter, Assembly and District Council.

Any Board of Directors member except the President, Vice President or Secretary-Treasurer may be recalled by an affirmative vote of two-thirds (2/3) of the members of that district voting. The recall shall be conducted pursuant to OCSEA State By-Laws Article X.
