RATIONALE: For ease of reference for OCSEA members and subordinate body leadership. To allow for subordinate bodies and members to offer checks and balances to the State Board of Directors when creating policies affecting the members and leaders of the Union. This is a member driven Union, so the members need to have a voice when these policies are created and implemented.

BE IT RESOLVED THAT ARTICLE V OF THE OCSEA STATE CONSTITUTION BE AMENDED AS FOLLOWS:

Article V – Duties of Board of Directors

Section 1. Fiscal Responsibility

4 The Board of Directors shall be responsible for an annual operating budget and such 5 budget shall be limited to the anticipated income for a given budget period. The Board of 6 Directors shall carry out the mandate and policies laid down by conventions, within one hundred 7 eighty (180) days following adjournment, and shall have full power to take such actions as are 8 necessary and expedient to attain maximum operating efficiency and to give substance to the 9 purposes of the Union. At least twelve (12) months in advance, the Board of Directors shall fix 10 the date and location of the regular biennial convention.

12 Section 2. Bonding of Officers and Agents

13 A surety bond in such amount as the Board of Directors shall determine shall be given by 14 the Secretary-Treasurer of the Union, and such officers and employees as may be required by the 15 Board of Directors, and the premium for such bond, or bonds, shall be paid by the Union.

Section 3. Documents, Property, Funds Held in Trust

18 All officers and members of the Board of Directors shall, upon their removal from office 19 or their resignation or at the expiration of their terms, surrender to the Secretary-Treasurer of the 20 Union all records, documents of a confidential nature, property and funds of the Union within 21 their possession or control. 22

23 **Section 4. Board Policies**

24 (A) All policies of the Board of Directors shall be provided to all Chapter, District 25 Council, and Assembly presidents within sixty (60) days of their passage and shall be made 26 easily accessible on the OCSEA website.

(B) Board policies shall expire on the eve of each the Biennial Convention held in 2023.

28 (C) Board policies not in conflict with constitutional or by-laws changes shall resume full

29 force and effect upon the close of each the biennial convention held in 2023; at which time,

30 they will be added to the back of the OCSEA AFSCME Constitution and By-Laws

 changed by the voting percentage required to change the underlying provision, i.e., two-thirds
 (2/3) if it applies to a state constitutional provision or a majority if it applies to the State By-laws

43 Section 5. Board of Directors Powers

(A) The Board of Directors shall have the power to make an official ruling and/or board
 policy. Such ruling or policy shall be binding on the Chapter, District Council or Assembly
 involved.

47 (B) No member of the Board of Directors shall sit in judgment and render decisions
48 involving any irregularity in the Chapter, District Council or Assembly of which he or she is a
49 member.

(C) In the event of layoff, demotion, termination, reduction in pay, status, or suspension,
each OCSEA non-contract staff member shall have the right to an appeal. The appeal shall be
heard before a mutually agreed upon uneven number of members from the Board of Directors.

55 Section 6. Call for Presidents' Conference

56 The Board of Directors shall call a conference of presidents biennially, in years in which 57 there is no regular convention.
