The so-called “Big Beautiful Bill,” passed by yes-men in Congress and signed by President Trump, will inflict serious harm on working families and public services across Ohio.

That’s because the new law makes the biggest cuts ever to the services that families in Ohio depend on — all to pay for huge tax cuts for billionaires and greedy corporations who don’t need another dime.

Working families and retirees are already facing a cost-of-living crisis, and this law makes it worse by driving up health care, grocery and energy costs. It also directly threatens AFSCME jobs by slashing the funding that supports our work.

The top 0.1% will receive a tax cut of ~~\$286,440~~ on average.

- WEAKER CONTRACTS IF EMPLOYERS POINT to the NEW LAW'S CUTS to SAY THEY ARE UNABLE to PAY for COLAS, ACROSS-THE-BOARD INCREASES or RISING HEALTH CARE and OTHER BENEFIT COSTS**
