OCSEA leaders, staff participate in massive member outreach

OCSEA leaders and staff converged the weekend of March 17-19 to participate in the greatest member outreach that OCSEA has ever seen. With contract negotiations approaching later this year, and the election of the OCSEA Bargaining Team this summer, OCSEA's top goal is to reach out to every single member.

Over two days, OCSEA leaders reached out to nearly 5,800 members and spoke directly to 1,600 of them about bargaining priorities, benefits and the upcoming budget impact on state services. Union leaders will continue to reach out to the membership for a one-on-one dialogue throughout the spring and summer.

In years past, OCSEA has sent out bargaining surveys to gather the input of its members. But with only a 10% return rate, OCSEA Pres. Chris Mabe thought it would be more productive to call members directly to determine their bargaining priorities and to talk about all the issues impacting the membership.

"We've had so many meaningful and constructive conversations with our rank-and-file membership about the direction we should take this round of bargaining," said Mabe. "Our members really are in tune with their jobs and the improvements that need to made. We're really inspired as we move forward to keep the conversation going."

OCSEA members will elect their Bargaining Team on

July 8 at the DoubleTree by Hilton Hotel in Columbus beginning at 8 a.m. Any member in good standing can attend and run.

General Assembly wages attacks on benefits, agencies and unions

The attack on public employees and their benefits are well underway in the Ohio General Assembly. Several pieces of legislation attack employees where it hurts—the health care wallet.

Premium increase sought

State Representative Derek Merrin (R), District 47, is looking for co-sponsors to a bill that would require exempt employees to pay a premium for dental, vision and life insurance.

For years, OCSEA has successfully negotiated to keep dental and vision free of a premium payment from members. Now, if the bill picks up steam, the Ohio state legislature would require exempt employees to pay as much as 15 percent of their premium for these services. Merrin's legislation would also direct the state to seek an identical provision for OCSEA members and all unionized

state employees in their collective bargaining agreements.

Dangerous dental bill is back

A bill reintroduced in the Ohio Senate would prevent insurance companies from negotiating lower prices on non-covered dental services. Senate Bill 87–the Dental Bill–would have a direct impact on OCSEA members who get their dental benefits through the Union Benefits Trust.

SB 87 would prevent benefit administrators, such as Delta Dental, from offering savings to enrollees on non-covered services. In addition to negotiating fees for covered benefits, like fillings and cleanings, insurance companies currently have the right to negotiate lower prices on non-covered services, like laughing gas for children.

If the bill passes, those agreements would not

be permitted and dentists would be allowed to charge unlimited fees for non-covered services.

More attacks on workers:

- Sunset Review bills, Senate Bill 79 and House Bill 51, would give small committees of legislators the ability to eliminate or "sunset" entire state agencies if they feel that those agencies are inefficient or ineffective. The bills were introduced by Rep. Keith Faber (R), District 84, and Sen. Kris Jordan (R), District 19. This is Faber's second attempt to dismantle state agencies. Many attribute his hard-line on government efficiency to no more than resume building since it's likely he'll run for State Auditor in 2018.
- Both public and private "Right-to-Work" bills have been introduced by the Ohio legislature
